## The Mortgager further covenants and agrees as fellows:

- (1) That this mortgage shall secure the Martgages for such fur than sums as may be advanced hereafter, at the option of the Mortgages, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
