ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, being known and designated as lot 9 and the adjoining 25 feet of lot 10 of a subdivision known as Paris View, Section \$1, as shown on plat thereof being recorded in the RMC Office for Greenville County in Plat Book VV, Page 101, and having the following metes and bounds:
