entry of a judgment cub reing this Mangage if: (a) Barower pays Lender all sums which would be then due under this Mangage, the Note and rotes securing Future Advances, if any, had no acceleration occurred; this Borower cures all breaches of any other coverants or agreements of Borrower contained in this Mortgage.
