The mortgagor does hereby covenant and agree to procure and maintain insurance in the amount of not less

hereby assigns the rents and profits of the above described premises to the said mortgage..., or its successors Heirs, Executors, Administrators or Assigns and agree that any Judge of the Circuit Court of said State, may, at chambers or otherwise, appoint a receiver, with authority to take possession of said premises and collect said rents and profits, applying the net proceeds thereof (after paying costs of collection) upon said debt, interest, cost of expense; without liability to account for anything more than the rents and profits actually collected.
