THIS MORTGAGE is made this	15th	November day of

WHEREAS, Borrower is indebted to Lender in the principal sum of <u>Fifty-one Thousand</u>

O. Riddle, dated October 12, 1973, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-R at page 91, and having according to said plat the following metes and bounds, to-wit:
