As recorded in the records of the RIC Office for Greenville County, South Carolina the title is now vested in Minnie L. Smith and Ethel W. Poole by deed of James H. Gossett and Ethel D. Cossett as recorded in Deed Book 1054 at page 427 on April 11, 1977. IT IS HEREBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID SECOND LIE ON THE ABOVE DESCRIBED PROPERTY.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise

TO HAVE AND TO HOLD, all and singular the said Fremises anto the said mortgagee, its (his) successors, heirs and assigns forever.

AND I (we) do hereby blind my (our) self and my four) heirs, executors and administrators, to produce or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee its (his) hers, successors and assigns, from and against all persons lawfully claiming, or to claim the

AND IT IS AGREED, by and between the parties here to, that the said mortgagor(s) his (their) neits, executors, or administrators, shall keep the buildings on said premises, insured against less or damage by fire, for the benefit of the said mortgages, for an amount not less than the impaid balance on the said. Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) helds, successors or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment.
