ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Clearview Circle and being known and designated as Lot No. 2 on plat of CLEARVIEW ACRES Subdivision recorded in the RMC Office for Greenville County in Plat Book MM at Page 168 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
