NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended. Code of Laws of South Carolina (1976): (i) all future advances and readvances that may subsequently be made to Mortgagor by Mortgagea evidenced by the aforesaid Note, or by other promissory notes, and all renewals and extensions thereof; and (ii) all other indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby not to exceed \$ 62,711.11----- plus interest thereon, all charges and expenses of collection incurred by Mortgagee

including court costs and reasonable attorneys fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

ALL that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the Northeastern side of Halidon Road, in the City of Greenville, Greenville County, South Carolina, being shown and designated as Lot No. 7 and a portion of Lot No. 5 on a plat of BARKSDALE, property of Huguenin & Douglas, made by Dalton & Neves, Engineers, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, pages 118 and 119, and having, according to a survey of the revision of Lots 3, 4, 5, 7, 9 and 10 of Barksdale, made by Campbell and Clarkson, dated February 21, 1969, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Halidon Road at the joint front corners of Lots No. 7 and 8 and running thence along the common line of said lots, N. 39-09 E., 226.8 feet to an iron pin; thence N. 15-00 E., 48.6 feet to an iron pin; thence along a new line, N. 15-00 E., 28.3 feet to an iron pin; thence along a new line, N. 29-45 W., 22.1 feet to an iron pin; thence along a new line, S. 62-15 W., 36.7 feet to an iron pin; thence along the line of Lots No. 5 and 6, S. 67-45 W., 265 feet to an iron pin on Halidon Road; thence along the Northeastern side of Halidon Road, S. 39-12 E., 200 feet to an iron pin, the point and place of beginning.
