Unless For over and Lender agree to other terms of payment, such am units shall be payable up in notice from Lender to Borr wer requesting payment there found shall bear interest from the date of disbursement at the rate payable from time to time on outstanding principal under the Note unless payment of interest at such rate would be contrary to applicable law, in which event such am units shall hear interest at the highest rate permissible under applicable law. Nothing contained in this paragraph 7 shall require Lender to incur any expense or take any action hereunder.

- S. Inspection. Lender may make or cause to be made roos nable entries up in and inspections of the Property, provided that Lender shall give Borower in tice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.
- 9. Condemnation. The proceeds of any award or claim tor damages, direct or confequential, in connection with any confermation or other taking of the Property, or partithers foor for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender.

In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise parce in writing, there shall be applied to the sums secured by this Mortgage such properties of the proceeds as is equal to that proportion which the armount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

- 12. Remeties Cumulative. All remedies provided in this Mertgage are distinct and cumulative to any other right or remedy under this Mertgage or afforded by law or equity, and may be exercised concurrently, independently or successively.
- 13. Successors and Assions Bound; Joint and Several Liability; Captions. The covenants and agreements herein contained shall bind, and the rights hereunder shall inure to, the respective successors and assigns of Lender and Borrower, subject to the provisions of paragraph 17 hereof. All covenants and agreements of Borrower shall be joint and several. The captions and headings of the paragraphs of this Mirrgage are for convenience only and are not to be used to interpret or define the provisions hereof.
- 14. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Borrower provided for in this Morrgage shall be given by mailing such notice by certified mail addressed to Borrower at the Property address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail, return receipt requested, to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein. Any notice provided for in this Morrgage shall be deemed to have been given to Borrower or Lender when given in the manner designated herein.
- 15. UNIFORM MORTGAGE: GOVERNING LAW: SEVERABILITY. This form of mortgage combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.
