"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land situate, lying and being on the southern side of Danhart Street in Gantt Township, Greenville County, South Carolina, being snown and designated as Lots Nos. 1,2 and 3 on a plat of "Cutler Ridge", made by C. O. Riddle, Surveyor, dated November, 1962, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "YY", at page 107, reference to said plat being craved for a complete and detailed description thereof.

This conveyance is made subject to any and all restrictions, convenants, conditions zoning ordinances, rights of way and easements affecting said lots.

This being the same property conveyed to the Grantor and A. I. Madeira by deed of Lots, Inc., on February 16, 1968, recorded in Deed Book 838, at page 53. The said A. I. Madeira having died intestate on November 12, 1978, leaving the Grantor and Robert L. Madeira as his heirs, according to Greenville County Probate file No. 1538 apt. 13; Robert L. Madeira having conveyed his interest in said property to Ella S. Madeira on November 21, 1978, in deed obook 1092, page 411.
