BEGINNING AT AN IRON PIN ON THE EAST SIDE OF CHANDLER STREET AT THE JOINT CORNER OF LOTS NOS 96 AND 97, WHICH POINT IS 350 FEET NORTH FROM THE NORTHEAST CORNER OF THE INTERSECTION OF MARTIN STREET AND CHANDLER STREET, AND RUNNING THENCE ALONG THE JOINT LINE OF LOTS NOS 96 AND 97, S 89 1/2 E 140 FEET TO AN IRON PIN ON A 10 FOOT ALLEY THENCE ALONG THE LINE OF SAID ALLEY, N. 11 1/2 W. 50 FEET TO AN IRON PIN, JOINT REAR CORNER OF LOTS NOS 96 AND 95- THENCE ALONG THE JOINT LINE OF SAID LOTS N. 89 1/2 W. 140 FEET TO THE JOINT CORNER OF SAID LOTS OF CHANDLER STREET, WHICH POINT IS 155 FEET SOUTH OF THE INTERSECTION OF GREENE STREET- THENCE ALONG THE EAST SIDE OF CHANDLER STREET, S 11 1/2 E 50 FEET TO THE BEGINNING CORNER.
