## MORTGAGE OF REAL ESTATE

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that piece, parcel or lot of land in Greenville County, South Carolina, situate, lying and being on the north side of Ledbetter Road and the west side of Chandler or Manley Road and being known as an 8.03 acre parcel on survey for Dr. Walter A. Chandler, Jr., as prepared by W. R. Williams, Jr., Engineer and Surveyor, dated March 25, 1979, said plat being recorded in the RMC Office for Greenville County in Plat Book 7-I at Page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a nail cap in the center of the intersection of Ledbetter Road and Manley Road and running thence with the center of Ledbetter Road S. 68-52 W. 222.5 feet to a nail cap; thence continuing with the center of Ledbetter Road, S. 69-52 W. 336.8 feet to a nail cap; thence N. 43-56 W. 578.9 feet to an iron pin; thence N. 60-39 E. 681 feet to an iron pin; thence S. 30-43 E. 237.2 feet to an iron pin; thence S. 48-55 E. 56.9 feet to an iron pin; thence S. 40-02 W. 137.5 feet to a nail cap in the center of Chandler or Manley Road; thence with the center of said Road, S. 60-56 E. 330 feet to a nail cap, the point of beginning.

This being the property conveyed to the mortgagor and Walter A. Chandler, Jr., by H. L. Rosamond, etal by deed dated June 25, 1979, recorded July 2, 1979, in Deed Book 1105 at Page 930; Walter A. Chandler, Jr.'s one-half interest being edeeded to mortgagor herein by deed dated October 20, 1980, and recorded October 21, 1980, in Deed Book 1135 at Page 853.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided berein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
