Lender's written agreement or applicable law. Borrower shall pay the amount of all mortgage itsurance properties in the

manner provided under paragraph 2 hereof.

Any amounts disbursed by Lender pursuant to this paragraph 7, with interest thereon, shill become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment thereof, and shall bear interest from the date of disbursement at the rate payable from time to time on outstanding principal under the Note unless payment of interest at such rate would be contrary to applicable law, in which event such amounts shall bear interest at the highest rate permissible under applicable law. Nothing contained in this paragraph 7 shall require Lender to incur any expense or take any action hereunder.

8. Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that I ender shall give Borrower notice prior to any such inspect on specifying teasonable cause therefor related to I ender's

9. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in hell of condemnation, are hereby assigned

Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by I ender to any successor in interest of Borrower shall not operate to release, in any manner, the liability of the original Borrower and Borrower's successors in interest. Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Botrower and Botrower's successors in interest

12. Remedies Cumulative. All remedies provided in this Mortgage are distinct and cumulative to any other right or temedy under this Mortgage or afforded by law or equits, and may be exercised concurrently, independently or successively

13. Successors and Assigns Bound: Joint and Several Liability: Captions. The covenants and agreements berein contained shall bind, and the rights bereunder shall inute to, the respective successors and assigns of Lender and Borrower. subject to the provisions of paragraph 17 hereof. All covenants and agreements of Bottower shall be joint and several The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions bereof.

14. Notice. Except for any notice required under applicable law to be given in another manner. (a) any notice to Borrower provided for in this Mortgage shall be given by mading such motice by certified mail addressed to Borrower at the Property Address or at such other address as Borrower may designate by morrie to Lender as provided herein, and this any notice to I ender shall be given by certified mail return recept requested, to I ender's address stated herein or to such other address as I ender may designate by notice to Borrower as provided herein. Lender shall have waived such option to accelerate if prior to the sale or transfer. Lender and the person to whom the Property is to be sold or transferred reach agreement in writing that the credit of such person is satisfactory to Lender and that the interest payable on the some seconed by this Mottgage shall be at such rate as Lender shall request. If I ender has waived the option to accelerate provided in this parsgraph 17, and if Borrower's successor in interest has executed a written assumption agreement accepted in writing by Lender.
