TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

And said Mortgagors, for themselves and their heirs, legal representatives, successors and assigns, hereby jointly and severally coverant and agree to and with said Mortgagee, its legal representatives, successors and assigns:

- 1. To pay all and singular the principal and interest and the various and sundry sums of money payable by virtue of said promissory note, and this mortgage, each and every, promptly on the days respectively the same severally become doe

- 4. To remove or demolish no buildings on said premises without the written consent of the Mortgagee; to permit, commit or suffer no waste, impairment or deterioration of said property or any part thereof and to keep the same and improvements thereon in good condition and repair.

To pay all and singular the costs, charges and expenses, including reasonable lawser's fees and cost of abstracts of title, incurred and goad at any time by said Mintgagee because and or in the event of the failure on the pair of the said Mintgagees to duly, promptly and fully perform, discharge, execute, effect, complete, comply with and alide by each and every the simulations, agreements, conditions and coverants of said promissory note, and this mortgage, any or either, and said costs, charges and expenses, each and every shall be immediately due and payable, whether or not there be notice, demand, attempt to collect or suit pending, and the full amount of each and every such payment shall bear interest from the date thereof until goad at the rate of seven per cent per annum; and all costs, charges and expenses so incurred or paid, tigether with such interest, shall be secured by the lien of this mortgage.
