That he hereby assigns all the rents, issues, and profits of the mortgaged premises from and after any default hercunder, and should legal proceedings be instituted pursuant to this instrument, that the Morigagee shall have the right to have appointed a receiver of the rents, issues, and profits, who, after deducting all charges and expenses attending such proceedings and the execution of his trust as receiver, shall apply the residue of the rents, issues, and profits toward the payment of the debt secured hereby.
