"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land situate, lying and being in Highland Township, County of Greenville, State of South Carolina, about one mile south of Liberty Church, west of and near South Carolina Highway 14, contianing 3.34 acres and being more particularily described and delineated on a survey made for Budd Williamson by Wolfe and Huskey Inc., Engineering and Surveying, Lyman, SC, dated July 17, 1978 and recorde in Plat Book 6-R at page 92 in the RMC Office for Greenville County.
