"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Shawn Drive and being known as Lot No. 33 of a subdivision known as Rustic Estates, as shown by plat of Werber Co., Inc. by R. B. Bruce, Carolina Surveying Company dated August 13, 1980, and having, according to said plat, the following metes and bounds, to-wit:
