AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in _ County, South Carolina:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 23 on plat of Chestnut Hills recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG, at Page 35, and also recorded in Plat Book GG, at Pages 64 and 65, and having, according to said plats, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Farmington Road, joint front corner of Lots Nos. 22 and 23, and running thence with the common line of said lots, S. 73-19 E. 135.3 feet to a point; thence N. 15-30 E. 75 feet to a point; thence with the common line of Lots Nos. 23 and 24, N. 76-27 W. 138.3 feet to a point on the edge of Farmington Road; thence with said Road, S. 13-03 W. 70 feet to a point, the point of beginning.

This being the same property conveyed to the mortgagors herein by deed of H. E. Tilley recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Volume 1073 at Page 571 on February 10, 1978.

This mortgage is second and junior in lien to that mortgage given in favor of First Federal Savings and Loan Association in the original amount of \$22,000.00 recorded in the R.M.C. Office for Greenville County, South Carolina, on June 29, 1973 in Mortgage Book 1283 at Page 161.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heaters (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; Hat the premises are free and clear of all encumbrances except for a prior Mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

In the event of the passage after the date of this Mortgage of any law imposing a federal, state or local tax upon Mortgage or debts secured thereby, the 'Whole principal sum (together with interest) secured by this Mortgage shall, at the option of Mortgagee, its successors and assigns, without notice become immediately due and payable.
