- (3) That it will keep all ingresserve to resolving or hereafter erected in good repair, and, in the case of a construction ban, that it will continue construction until completion without interruption, and should it had to do so, the Motgages may, at its option, enter upon said premises, make whetever require are recessary, including the completion of any construction work underway, and charge the expenses for such regains or the completion of such construction to the meetingse delt.
- (4) That it will pay, when doe, all taxes, publy assessments, and other consensual or municipal charges, fixes or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
