tificate. If said affidavit or renunciation of dower is made outside of South Carolina, it must be taken by a Notary Public or a Clerk of Court of Record or a Commissioner of Deeds for South Carolina whose official

seal must be impressed thereon. If the Mortgagor is a man and has no living wife, his status should be indicated following his name on the first line of the mortgage on page 1, thus: "Whereas, I, John Doe, an unmarried man" or "John Doe, a widower, of the County and State," etc.
