- 4. The Maker acknowledges, represents, warrants, and confirms to the Payee the following: (a) the Primary Mortgages are valid and binding and free from all infirmities of any nature whatsoever; and (b) the Primary Mortgages constitute a first lien against the property encumbered thereby.
- 5. It is further agreed that execution of this agreement shall not release the Maker or any other party to the Primary Note or any undertaking in connection therewith, nor shall this Agreement effect any release of any collateral given at any time to secure payment of the Primary Note or said undertakings.
- 6. The Maker represents that no consent of any person, firm, or corporation not a party hereto is required, and the Maker agrees to indemnify and hold harmless the Payee from and against any and all claims, demands, expenses, losses, damages, or liability whatsoever, including attorneys' fees, arising out of the failure to obtain the consent of any person not a party hereto.
- 7. It is further agreed that nothing herein shall mean or be construed to call for a rate of interest in excess of that allowed to be charged by the State of South Carolina or of the United States and that, if the provisions hereof shall be determined to call for a rate of interest in excess of the maximum rate allowed by said laws, then immediately and without necessity of any further action, the interest rate herein provided shall be retroactively reduced to the maximum rate allowed by said laws.
- 8. In all other respects, the said Primary Note and Primary Mortgages are hereby ratified and affirmed and remain unchanged and in full force and effect.
- 9. This Agreement shall be binding on the parties hereto and their successors and assigns.
