ALL that piece, parcel or lot of land situtate on the southwestern side of Laurens Road in Greenville County, State of South Carolina, and being the southern portion of Lot 25 on a plat of a survey made by R. A. Moore, March, 1945, recorded in Plat Book Q at Page 116 in the RMC Office for Greenville County and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Laurens Road at the south-eastern corner of property now or formerly owned by Frank S. Leake and James L. Leake and running thence along said Laurens Road, S. 55-42 E. 4 feet to an iron pin; thence S. 59-22 W., 169.2 feet to an iron pin in the rear of Julian-Singleton property; thence S. 54-46 W. 10 feet to an iron pin in the rear of the Leake property; thence along line of Leake property, N. 61-53 E. 168.9 feet to the beginning point. This is the same property conveyed to Frank S. Leake and James L. Leake by deed recorded in Deed Book 343 at Page 379 in the RMC Office • for Greenville County.
