Administration providing for nondiscrimination and equal opportunity in housing. It is understood and agreed that failure or refusal to comply with any such provisions shall be a proper basis for the secretary to take any corrective ection he may deem necessary, including, but not limited to, the rejection of future applications for FMA mortgage incurance and the refusal to enter into future contracts of any kind with which the Owner is identified; and further, the Secretary shall have a similar right of corrective action (1) with respect to any individuals who are officers, directors, principal stockholders, trustees, managers, partners or associates of the Cuner; and (2) with respect to any corporation or any other type of business association or organization with which the officers, directors, principal stockholders, trustees, minagers, partners or associates of the Owner may be identified.


