"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, being known and designated as Lot No. 89 on a plat of "Addition to Knollwood Heights" of record in the RMC Office for Greenville County in Plat Book 4-F at Page 17 and having, according to said plat, such metes and bounds as are more fully shown thereon.

This being the same property conveyed to Ted C. Russell and Jackie M. Russell by deed of Leon Hickman and Edna Lee Hickman dated and recorded November 4, 1977, in Book 1067 at Page 977. Jackie M.
