"ALL, that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 266 on a Plat of CANEBRAKE III, prepared by Arbor Engineering, Inc., dated November 1980 and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7X, Page 87, and revised in Plat Book 7X, Page 97, reference to which is hereby craved for the metes and bounds thereof.

The above described property is the same property conveyed to the Mortgagor herein by deed of College Properties, Inc., dated August 20, 1982 to be recorded herewith.

The within Mortgage is junior in lien to that mortgage given to First Federal Savings and Loan Association in the amount of \$71,200.00 dated August 20, 1982 and recorded in the RMC Office for Greenville County, South Carolina, on August20, 1982, in Mortgage Book 1578 , Page 316.

Mortgagor further covenants and agrees:

- 1. To keep monthly payments current at all times on any first mortgage loan that my be secured by the within described property. Should mortgagor become sixty (60) days or more delinquent on any such first mortgage loan, the mortgagee herein, at its option, may accelerate all remaining payments due hereunder declaring the entire balance due and payable, together with cost and fees and commence mortgage foreclosure proceedings in accordance with the laws of this state.
- 2. To not abandon construction work to be performed on the premises for a period of two (2) weeks or longer.
- 3. To complete all construction of the dwelling to be placed on the premises not later than six (6) months from the date of the within mortgage.

Failure to comply with said covenants shall constitute a default on the within mortgage.
