indebtedness outstanding at any one time secured hereby not to exceed \$8,984.40 , plus interest thereon, all charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

ALL that certain piece, parcel or lot of land with all improvements thereon located in Greenville Township, Greenville County, South Carolina, and being known and designated as Lot No. 103 on the east side of West Faris Road in a subdivision known as Augusta Circle and, according to a plat of said subdivision recorded in the RMC Office for Greenville County in plat book "F" at page 23, having the following metes and bounds, to-wit:
