BEGINNING at an iron pin on the Southern side of Hampshire Drive, the joint front corner of Lots \$56 and \$55, and running thence along the line of these lots, S. 2-00 E. 135.6 feet to an iron pin at the joint rear corner of said lots; running thence N. 77-37 E. 186.1 feet to an iron pin at an intersection, which intersection is curved, the chord of which is N. 20-07 W. 85.0 feet to an iron pin on the Southern side of Hampshire Drive; running thence along the Southern side of Hampshire Drive, N. 70-07 W. 85.0 feet to an iron pin; thence continuing along the Southern side of Hampshire Drive N. 84-43 W. 85.5 feet to an iron pin, the point of beginning.
