Capital Bank & Trust, its successors and assigns forever:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Fork Shoals Rd. (also known as Pearson Rd.) containing 10.4 acres as shown on a plat of property of Billy R. and Patricia L. Mahaffey dated April 14, 1966, by Carolina Engineering and Surveying Company, recorded in the RMC office for Greenville County in Plat Book MMM at Page 91 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin near the center of Pearson Rd. and running thence along the property now or formerly of Pearson as shown on said plat, S 4-0 W 1549.7 ft. to iron pin; thence S 66-53 W 316.0 ft. to iron pin on the line of property of Anthony J. Maurer; thence with the Maurer line N 4-0 E 1681.5 ft. to an iron pin near the center of Pearson Rd.; thence along the center of said road, S 84-33 E 130.0 ft.; thence continuing along the center of said road, N 89-15 E 150.0 ft. to an iron pin, the point of beginning.
