

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being located on the Southerly side of East Georgia Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of East Georgia Road at the joint corner of property of H.V. Grogan and running thence along the southerly side of East Georgia Road in a general N. 85-50 E. direction 625 feet, more or less, to a point at the intersection of East Georgia Road and Fowler Road; thence S. 6-33 W. 175.5 feet to an iron pin; thence S.71-31 E. 168.3 feet to an iron pin; thence with the line of property of W.C.
