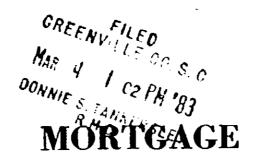

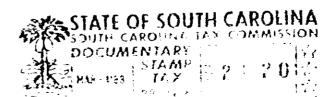

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Drury Lane and being shown and designated as Part of Lot 41 on plat of GLENDALE, recorded in the RMC Office for Greenville County in Plat Book GG, Pages 32 & 33 and also shown on a more recent plat prepared by Freeland & Associates, dated August 1, 1979, entitled "Property of George H. O'Shields, Jr. and Margaret J. O'Shields" and recorded in the RMC Office for Greenville County in Plat Book 7M, Page 15, and having according to the more recent plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Drury Lane and running thence S. 16-54 W. 162.6 feet to an iron pin on Haverhill Street; thence with said Haverhill Street as follows: N. 78-44 W. 34.6 feet to an iron pin; thence N. 33-45 W. 60.9 feet to an iron pin; thence turning and leaving Haverhill Street and running along the line of Lot No. 42, N. 54-20 E. 164.8 feet to an iron pin on Drury Lane; thence turning and running along Drury Lane, S. 49-49 E. 77.7 feet to an iron pin, the point of beginning.
