- (7) That the Mortgagor shall hold end enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. - (8) That the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective halrs, executors, administrators, successors and assigns, of the parties hereto. Whenever used, the singular shall included the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
