NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located Greenville County, South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the northeast side of Thornwood Drive, near the City of Greenville, in Greenville County, S.C., being shown as Lot No. 89 on Plat of Section 2 of Thornwood Acres, made by J. Mac Richardson, Engineer, April 1959, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book MM at Page 105 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Thornwood Drive at the joint front corner of Lots 88 and 89 and running thence along the line of Lot 88 N. 74-34 E. 150 feet to an iron pin; thence N. 40-19 W. 78.5 feet to an iron pin; thence with the line of Lot 90 S. 47-34 W. 152.4 feet to an iron pin on the northeast side of Thornwood Drive; thence along Thornwood Drive S. 41-45 E. 80 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including buy not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heater (all of which are declared to be a part of said real estate whether physically attached thereto or not).

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 0 1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above-mentioned Note and all payments required by any note(s) secured by lien(s) having priority over Mortgagee's within described Olien or by any prior mortgage(s) in the amounts, in the manner and at the places set forth therein. This Mortgage →secures payment of said Note according to its terms, which are incorporated herein by reference.
  - 2. TAXES. Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly deliver the official receipts thereof to the Mortgagee upon demand; and in default thereof the Mortgagee may pay the same and add the amount of such payment(s) to the principal indebtedness due Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand.
