C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Critzens Building and LOAN Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Cross Road Baptist Church, Butler Township, and shown on plat of property entitled "Property of Cohen H. & Dale P. Satterfield", prepared by John A. Simmons, R.L.D. dated July 8, 1977, and to be recorded herewith, and containing, according to said plat 1.84 acres, more or less, and having, according to said plat, the following courses and distances,

BEGINNING, atiron pin in center of Circle Road, joint front corner of 0.50 acre tract and 1.84 acre tract and runs thence as new line between said tracts, S. 54-29 E. 111.2 feet to iron pin; thence along new line of property of Dale P. Satterfield, S. 29-56 W. 429.7 feet to iron pin; thence as new line along other property of Cohen Satterfield, N. 56-58 W. 256.3 feet to iron pin in center of Circle Road; thence with said road, N. 42-51 E. 26.4 feet to iron pin; thence continuing with said Road, N. 47-21-E: 100 feet to iron pin; thence N. 50-34 E. 265 feet to iron pin; thence N. 45-30 E. 59.7 feet to the beginning corner.
