- (8) That the covenants herein contained shell bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors and essigns, of the parties hereto. Whosever used, the singular shall included the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
