ALL that certain piece, parcel or lot of land, together with all improvements thereon, cituate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Raintree Lane, being shown and designated as Lot No. 62 on plat of Pelham Woods Subdivision, Section I, which plat is recorded in the RMC Office for Greenville County in Plat Book 4-F, Page 33 and having metes and bounds as shown thereon.
