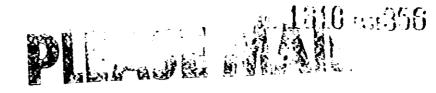

## **MORTGAGE**

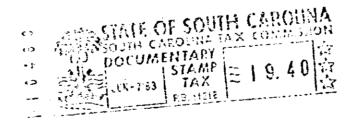
