AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located GREENVILLE County, South Carolina:

ALL that certain piece, parcel or lot of land, situate lying and being in the State of South Carolina, County of Greenville, City of Greenville, being known and designated as part of Lot 1 in Block O of the O.P. MILLS PROPERTY, according to a survey recorded in the R.M.C. Office for Greenville County in Plat Book F at Page 299, and being further shown on a more recent plat by Freeland and Associates, dated March 26, 1979, entitled "PROPERTY OF PAUL EUGENE CARBAUGH and BRENDA ELAINE LUSK CARBAUGH," and having, according to said plats, the following metes and bounds, to wit:

BEGINNING at an iron pin at the southwest corner of Grove Road and Arthur Avenue, and running thence along the west side of Grove Road, S. 18-37 W. 80 feet to an iron pin; thence N. 69-50 W. 146.5 feet to an iron pin on the east side of Arthur Avenue; thence around the curve of said Avenue, as follows: N. 53-57 E. 41.2 feet; thence N. 70-32 E. 42.2 feet; thence N. 87-38 E. 41.2 feet; thence S. 73-22 E. 50.9 feet to the beginning corner.

This being the same property conveyed to the Mortgagors herein by deed of Robert Stephenson Bruns, as executor of the Estate of Ailene S. Bruns, dated March 30, 1979 and recorded in the R.M.C. Office for Greenville County, South Carolina on March 30, 1979 in Deed Book 1099 at Page 539.

This mortgage is second and junior in lien to that certain mortgage granted in favor of Collateral Investment Company, dated March 30, 1979 and recorded in the R.M.C. Office for Greenville County, South Carolina on March 30, 1979 in Mortgage Book 1461 at Page 339.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including buy not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heater (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the premises are free and clear of all encumbrances except for a prior mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above-mentioned Note and all payments required by any note(s) secured by lien(s) having priority over Mortgagee's within described lien or by any prior mortgage(s) in the amounts, in the manner and at the places set forth therein. This Mortgage secures payment of said Note according to its terms, which are incorporated herein by reference.
- 2. TAXES. Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly deliver the official receipts thereof to the Mortgagee upon demand; and in default thereof the Mortgagee may pay the same and add the amount of such payment(s) to the principal indebtedness gue Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand.
