(4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines of other impositions against the mortgaged premises. (11) If mortgagor fails to pay any installment of principal or interest or any other amount on any prior mortgage when the same becomes due. mortgagee may pay the same, and mortgagor on demand will repay the amount so paid with interest thereon at the rate set forth in the note, and the same shall be added to the mortgage indebtedness and be secured by this mortgage. (12) If mortgagor is not personally obligated on the debt which this mortgage secures, mortgagor acknowledges that said loan was made in consideration for this mortgage and that mortgagor received consideration in this transaction.
