WHEREAS, the Mortgagor are jointly indebted to BENEFICIAL FINANCE CO. OF SOUTH CAROLINA, hereinafter called "Mortgagor", and have executed a Revolving Loan Agreement, hereafter referred to as the "Agreement", of even date with this Mortgage, by which Mortgagor is obligated to make loans and advances up to \$11,000.00, hereinafter referred to as the "Line of Credit", which shall be made pursuant to the provisions of the South Carolina Consumer Protection Code (CPA) and all other regulations of Mortgagor, under the terms and conditions of this Mortgage, it being hereby expressly agreed that upon default in the payment of the Agreement or of any charge in connection with the Mortgage, and otherwise, premiums, taxes or assessments or in the performance of any of the requirements as to taxes or insurance or of any of the other conditions contained in the Mortgage, subject to the provisions of the South Carolina CPA with respect to default and the right to cure the default, shall have the right to declare the Mortgage, subject to the collection of the Agreement, to be immediately due and owing, and to proceed to enforce the Lien and Principal Balance thereafter referred to as the "Legal Balance" set forth under the Agreement to be immediately due and owing, and to proceed to enforce the collection of the Agreement together with a reasonable amount not to exceed 15% of the Legal Balance for an attorney's fee concerning the debt, and all other amounts secured hereby.

NOW KNOW ALL MEN BY MORTGAGE, in order better to secure the payment of the above mentioned Agreement in accordance with its terms, and all other sums mentioned therein or herein, and also in consideration of the further sum of TEN DOLLARS to Mortgagor in hand and truly paid by Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, in this instrument, have granted, bargained, sold and Mortgaged at and before the sealing of these presents, the property herein described, acknowledged in this instrument, have granted, bargained, sold and Mortgaged, and by these presents do grant, bargain, sell and release unto Mortgagor, its successors and assigns, the real property situated in the County of Greenville, State of South Carolina, hereinafter denominated as the "Property", and described as follows:

ALL that certain piece, parcel or lot of land, together with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville in the Town of Simpsonville in the tract of Beirn's Court being shown as Lot No. 593 on a plan of Section 6, Sheet No. 1 of Westwood Subdivision as recorded in Plan Book X at page 1000 before the property conveyed to the mortgagor by deed of Brenda Laible recorded in Deed Book 1000 at page 703 on June 22, 1974.
