THIS MORTGAGE is made this 12th day of August, 1983, between **Mortagor, Steven D. Bichel**, (herein "Borrower"), and the Mortgeree, **AMERICAN FEDERAL BANK, FSB**, a corporation organized and existing under the laws of **THE UNITED STATES OF AMERICA**, whose address is **101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA**, (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Nine Thousand Four Hundred Fifty Six, No/100 (\$9,450.00) Dollars, which indebtedness is evidenced by Borrower's note dated August 12, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 1988.
