THE NOTE CONTAINS PROVISIONS ALEGWING FOR CHANGES IN THE INTEREST RATE AND MONTHLY PAYMENTS.

THE NOTE ALSO PROVIDES FOR CALCULATIONS OF TWO SEPARATE MONTHLY PAYMENT AMOUNTS. ONE WILL BE THE AMOUNT THE BORROWER MUST ACTUALLY PAY EACH MONTH. Beginning on the date of this Note, I will owe interest at a yearly rate of 12.375%. The rate of interest I will owe will change on the first day of March 1, 1984, and on that day every 6th month thereafter. Each date on which my rate of interest could change is called an "Interest Change Date." My new rate of interest will become effective on each interest Change Date.
