(C) Limit on My Unpaid Principal Baianne; required Full Payment Assaut

My unpaid principal bilance can never exceed a maximum amount equal to one hundred twenty-five percent (125%) of the principal amount I originally borrowed. If my paying the amount of my monthly payment calculated under Section 5 above after any Interest Change Date would cause my unpaid principal balance to exceed that miximum amount at any time, I will instead pay the Full Payment Amount as my monthly payment until the next time I may elect a Payment Increase Option under Section 5(B).

7. NOTICE OF CHANGES

The Note Holder will mill or deliver to me a notice of any changes in the Full Payment Amount and my monthly payment before the effective date of any change. The notice will include information required by law to be given me.

B. CHARGES; LIENS

Uniform Covenant 4 of the Security Instrument is amended to read as follows:

Charges: Liens. Borrower shall promptly discharge any lien which has priority over this Security Instrument; provided, that Borrower shall not be required to discharge any such lien which has priority over this Security Instrument; provided, that Borrower shall not be required to discharge any such lien so long as Borrower: (a) shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender; (b) shall in good faith contest such lien by, or derend against enforcement of such lien in, legal proceedings which in the opinion of Lender operate to prevent the enforcement of the lies or forfeiture of the Property or any part thereof; or (c) shall secure from the holder of such lien an agreement in a form satisfactory to Lender subordinating such lien to this Security Instrument.
