"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, on the eastern side of Wilton Street having, according to plat dated March 28, 1979 prepared by Jones Engineering Services, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Wilton Street, said iron pin being 129 feet, more or less, north of the intersection of Wilton Street and Randal Street; thence running with Wilton Street, N. 2-05 E. 80.5 feet to an iron pin; thence N. 89-07 E. 164.7 feet to an iron pin; thence N. 89-35 E. 74.8 feet to an iron pin; thence S. 4-36 W. 128.4 feet to an iron pin; thence N. 79-22 W. 243 feet to an iron pin, the point of beginning.
