"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being parts of Lots 19 and 20 in a Subdivision known as Hillcrest Circle as shown on plat recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book H, Page 129, and further described as follows:

BEGINNING at a point on the west side of Hillcrest Circle at the approximate center of Lot 20 and running thence with the west side of Hillcrest Circle N. 12-45 E., 75 feet to a point; thence N. 72-30 W., 158.6 feet to a point; thence S. 26-40 W., 75.8 feet to a point; thence S. 72-30 E., 178 feet to the point of beginning.
