Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loand and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville County, South Carolina:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being shown and designated as part of Lot 8 according to a survey of the Sinking Fund Commission District 17-A, N.W. Holcombe Tract, made by C. L. Furman, Jr., RLS, dated April, 1933, recorded in the R.M.C. Office for Greenville County in Plat Book H, Page 219 and having, according to a new plat prepared by Freeland & Associates, dated August 26, 1980, recorded in the said R.M.C. Office in Plat Book 8G, Page 5 and having, according to said plat, such metes and bounds as appear thereon.
