AND THE PROPERTY OF THE PARTY O

construed to include the cessation of the corporate existence of the Corporation resulting either from a merger or consolidation of the Corporation into or with another corporation or dissolution or liquidation of the Corporation following a transfer of all or substantially all of its assets as an entirety under the conditions permitting such actions with respect to the Corporation contained in section 7.02 hereof;

- The commencement by the Corporation of any (h) proceeding or other action relating to it in seeking reorganization, liquidation, composition dissolution, winding-up, arrangement, readjustment of its debts, or for any other relief, under any bankruptcy, insolvency, reorganization, liquidation, dissolution, arrangement, composition, readjustment of debt or other similar act or law of any jurisdiction, now or hereafter existing; or the application by the Corporation for a receiver, custodian or trustee of it or for all or a substantial part of its property; or the making by the Corporation of an assignment for the benefit of creditors; or the inability by the Corporation, or the admission in writing of its inability, to pay its debts as they become due; or the taking of any action by the Corporation indicating its consent to, approval of or acquiescence in, or in the furtherance of, any of the foregoing;
- The commencement against the Corporation of (i) any case, proceeding or other action in bankruptcy or dissolution, reorganization, liquidation, winding-up, arrangement, composition or readjustment of its any other relief, under any bankruptcy, debts, or liquidation, reorganization, dissolution, insolvency, arrangement, composition, readjustment of debt or other similar act or law of any jurisdiction, now or hereafter existing; or the appointment of a receiver, custodian or trustee of the Corporation or for all or a substantial part of its property or the issuance of a warrant of attachment, execution or restraint, or similar process against any substantial part of the property of the Corporation; and which in each such case such condition shall continue for a period of 60 days undismissed, undischarged or unbonded.
- (j) Any judgment against the Corporation in the amount of \$10,000 or more which is not promptly paid or promptly appealed and secured pending appeal; or
- (k) Any default in payment or acceleration of any indebtedness owed by the Corporation or any subsidiary.

The provisions of subsection (c) of this Section 9.01 are subject to the following limitations: if by reason of acts of God; strikes, lockouts or other industrial disturbances; acts of public enemies; orders of any kind of
