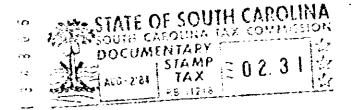
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 6 according to Plat of the Property of Mollie Fortner, et al., by R.E. Dalton, Engineer, recorded in the RMC Office for Greenville County in Plat Book F at Page 73, and being more particularly described as follows:

BEGINNING at a stake on the south side of Heatherly Drive, corner of Lot 5; thence with said Lot 5, S. 36 W. 219.8 feet to a stake; thence N. 55-43 W. 45 feet to a stake in the line of Lot 7; thence with said Lot 7, N. 34-34 E. 222.4 feet to a stake on the south side of Heatherly Drive; thence with said drive, S. 50-34 E. 50.3 feet to the point of beginning.

This being a portion of the property conveyed to the Mortgagor by deed of the Mortgagee, to be executed and recorded of even date herewith.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
