ALL that certain piece, parcel or lot of land situate, lying and being on the southern side of Pinedale Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 7 as shown on a plat prepared by R. K. Campbell, dated May 1950, revised July 9, 1959, entitled "Property Plat, P. L. Bruce, recorded in the R.M.C. Office for Greenville County in Plat Book MM at Page 123, and having according to said plat the following metes and bounds, to-wit:
