is hereby reduced to the extent necessary to eliminate such violation. The amounts of such interest or other charges previously paid to Lender in excess of the amounts permitted by applicable law shall be applied by Lender to repay the unpaid accrued interest account balance and then to reduce the principal of the indebtedness evidenced by this Note, or, at Lender's option, be refunded.

Notwithstanding the above, no subsequent usury limitation imposed by any applicable law will affect the validity or enforceability of the Note.


