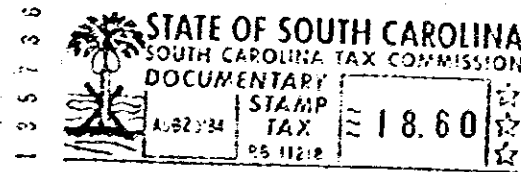

### MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on August 20, 1984. The mortgagor is GARY W. EMORY & CHRISTIANE R. EMORY ("Borrower"). This Security Instrument is given to INVESTORS SAVINGS AND LOAN ASSOCIATION, which is organized and existing under the laws of Virginia, and whose address is 5008 Monument Avenue, Richmond, Virginia 23230 ("Lender"). Borrower owes Lender the principal sum of SIXTY TWO THOUSAND Dollars (U.S. \$62,000.00). This debt is evidenced by Borrower's note dated the same date as this Security Instrument ("Note"), which provides for monthly payments, with the full debt, if not paid earlier, due and payable on September 1, 2014. This Security Instrument secures to Lender: (a) the repayment of the debt evidenced by the Note, with interest, and all renewals, extensions and modifications; (b) the payment of all other sums, with interest, advanced under paragraph 7 to protect the security of this Security Instrument; and (c) the performance of Borrower's covenants and agreements under this Security Instrument and the Note. For this purpose, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in Greenville County, South Carolina:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, known and designated as Lot No. 178, shown on a plat of the subdivision of WEDGEFIELD, SECTION II, recorded in the Office of RMC for Greenville County, S. C., in plat book 9-W page 11.

All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.
